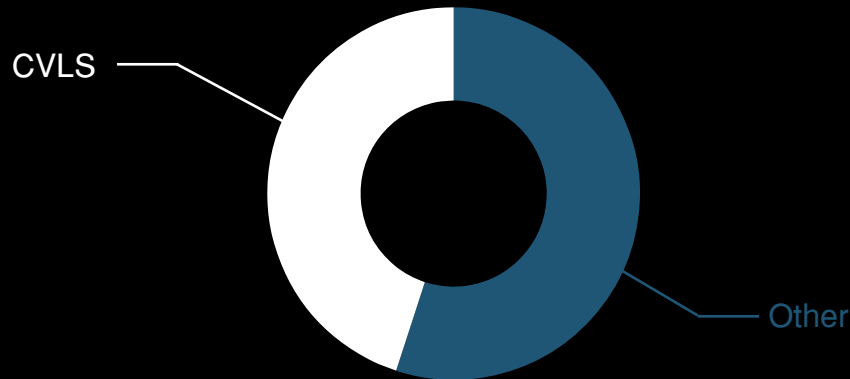
# WHY CVLS?
