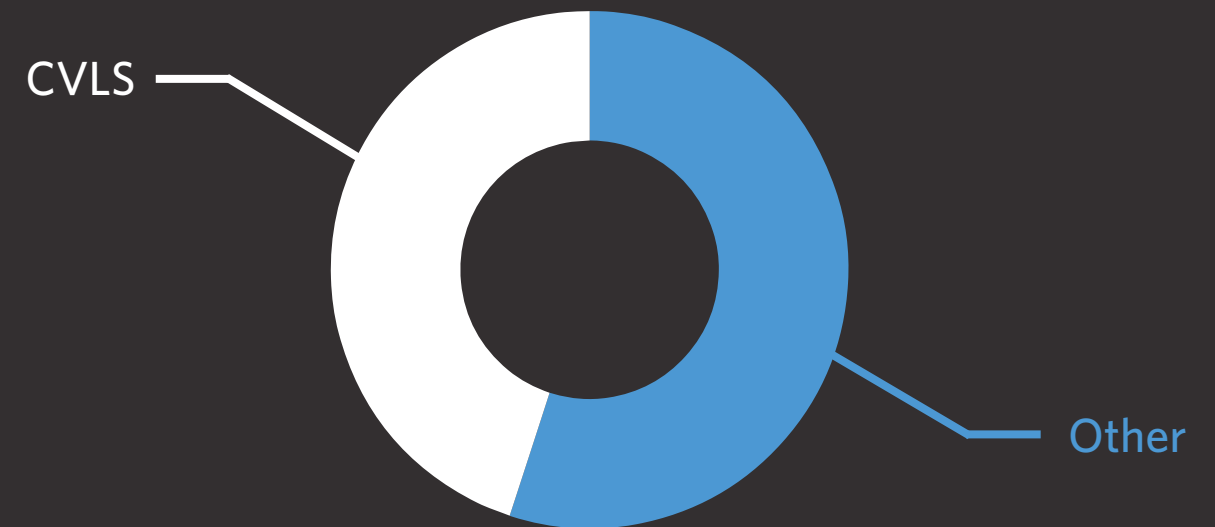
WHY CVLS?
